Class A Voting Member

Organizations must identify one member who will be the main contact and be entitled to voting privileges for the organization (CPA's by-laws state that each organization is entitled to only one vote). In addition to voting privileges, the Class A member is entitled to all benefits, privileges, and special member's rates for conference registration, training programs, etc.

Class B Non-Voting Member

An organization may hold multiple Class B memberships in addition to the single Class A voting member. With the exception of voting privileges, Class B members are entitled to all the benefits of membership.
