**Subject: Request for Emergency Financial Relief**

Dear Minister Morneau:

As a major employer in Canada, the parking industry engages an estimated 10,000 employees, many on the front line, along with numerous other direct and indirect positions. As a major contributor to the Canadian economy, the parking industry supports local communities in the management of on- and off-street parking, and contributes significantly to the transportation and logistics infrastructure, many of which are designated as essential services.

The parking industry is a hybrid between building management (an essential service) and hospitality. Facing unprecedented and devastating losses we still maintain our services with skeleton crews, as more than 85 percent of our workforce has been, or is being negatively impacted. Moreover, with reductions in parking demand, the nation's parking industry is suffering in scope not unlike the hospitality sector, hotels and airlines.

While we must keep our doors open to the general public and essential services, the drastic reduction in cash flow due to unprecedented drops in demand due to mandated business closures, self-isolation and other necessary limitations, is severely impacting companies in our industry. Also, our connection with real estate involves financial commitments that can vary depending on the severity of the conditions. Amid challenges in meeting our payrolls, which represents a significant portion of our operating expenses and unprecedented layoffs, we respectfully request that the Federal Government, alongside with its Provincial counterparts, consider the following:

1. Immediate relief in the form of deferred income and payroll taxes,
2. Deferred parking tax remittance,
3. Funding relief for Canadian-based equipment manufacturers and industry service providers that support the industry, and
4. Change in legislation to categorize the COVID-19 pandemic as a Force Majeure condition.

On behalf of the Parking Industry, I thank you for your consideration during these difficult and unsettling times. Our thoughts are with our members and their customers who are impacted by the COVID-19 pandemic. As the COVID-19 situation evolves, we will continue with our duties as stakeholders in the communities we serve to the best of our abilities, and sincerely hope you can assist our industry with the above critical items.
